We also occasionally serve survivors from a broader regional area (for example Buckingham County) because we may be the closest rape crisis center or because they may have come to UVA Hospital for the forensic exam. We don't charge for our services, and while we do receive grant funding, this does not cover all of our expenses. We rely on community support to provide these services.
